

**MJCCA FINANCIAL ASSISTANCE FAQ's**  
2026 Update for Camps, Schools, BBYO, and Club J

1. **Is financial assistance available to anyone who requests help for MJCCA programs?**
  - Financial assistance is only available to MJCCA Members in good standing at the time of registration. Any outstanding balances must be paid before your application will be considered.
  - You must be registered for camp/school before financial assistance is awarded.
  - If you are not a current MJCCA Member, you must first establish a membership before enrolling into a program. Summer membership must be paid in full or you must establish a credit/debit plan for payment before camp starts.
2. **How do I initiate the financial assistance process for my child's tuition?**
  - Submit your program registration.
  - Pay the required deposit and any required registration fee.
  - Please indicate on your camp or school registration form that you are requesting financial assistance.
  - Apply for financial assistance on-line <https://online.factsmgt.com/signin/4LCK6> - select the 2026-2027 school term.
3. **What documents are required?**
  - 1040/1040EZ or other 2023 Federal Tax Return, with all schedules, W-2 and 1099 Forms (2024 returns may be used until March 30, 2026.)
  - PLEASE NOTE: Please indicate on your application, your family AGI from your most recent jointly filed tax . If you file separately, please include AGI for both tax returns.
  - Current pay stubs for all applicants.
  - Copies of all supporting tax documents if you have business income/loss.
5. **Are there adjusted registration fees/deposits if I apply for financial assistance?**
  - Camp Barney Registration: You must pay the deposit of \$200 per child at time of registration to hold space. Your remaining camp fees will be charged based on a 25% discount until financial assistance is determined. Payment plans will be adjusted to reflect the award.
  - Day Camp: You must pay the deposit and registration fee for each child at time of registration to hold space. You will be charged monthly based on a 25% discount until financial assistance is determined. Payment plans will be adjusted to reflect the award.

**You must have a payment method set up for camp to be considered for financial assistance.**

6. **May I pay the deposit by one payment method and the balance of the fees by a different payment method?** The payment method used to for your deposit will be used for all future billing unless you contact the MJCCA Registration Team at 678-812-4010 to change your payment method.
7. **What happens if I miss a payment for camp or school?**  
If you default on the payment plan, your current and future financial assistance will be in jeopardy as well as your child's ability to participate in our programs. Camp Barney Medintz and preschool camp fees must be paid in full prior to the start of camp. We will consider extenuating circumstances on a case-by-case basis.
8. **What happens if I receive additional financial assistance from a source other than the MJCCA?**  
The MJCCA reserves the right to adjust all MJCCA financial assistance awards based on information regarding change in income or awards from outside sources toward tuition.
9. **Do I need a separate application in FACTS for each child attending MJCCA Camps or Schools?**  
**NO.** Only one Financial Assistance form per family is required for the 2026 summer camp season and 2026-2027 school year.
10. **What are the deadlines for financial assistance applications?**  
Financial assistance applications are accepted and reviewed on a rolling basis as long as funds are available.  
Priority will be given to those applications that meet these deadlines:
- Camp Barney Medintz for Summer 2026 : October 5, 2025
  - Weinstein School, Sunshine School and Schiff Schools for Camp 2026/School 2026-2027: January 31, 2026
  - Zaban Day Camps for Summer 2026- January 31, 2026
